Those who passed the course before three years (i.e. exceeding 36 Months) and those have gone through the apprenticeship training already through any organization or this organization are not eligible to apply for apprenticeship training of Kwar HE Project, CVPPPL Kishtwar. In other words, the gap between the date of declaration of results and date of engagement should not be more than 03 years (36 Months). As such only, pass out candidates who have completed the degree/ diploma courses after 01.01.2020 are eligible to apply.


- a. The above mentioned vacancies may increase or decrease as per the requirements of CVPPPL.


