1. How to Apply

- a. The candidate must go through the Terms and Conditions as mentioned in the notification.
- b. The candidate must have a valid mobile number and e-mail ID before Registering / Enrolling for Apprenticeship online on www.mhrdnats.gov.in .
- c. The candidate has to enrol himself/herself on www.mhrdnats.gov.in and get himself verified from the respective Regional Boards. After verification the student will receive 16 Digit Enrollment Number.
- d. The candidates who is having the 16 Digit Enrollment Number may proceed to apply online through the Google Form Link: **FILL OUT FORM**

2. **Educational Qualification:**

Only Indian Nationals Candidates should have passed the Graduate/Diploma in Engineering / Technology in the above-mentioned streams/field/trades/branches/discipline, recognized by AICTE/UGC, on or after 01/04/2019.

3. **Mode of Selection:**

1. Selection will be through **Interview**.
2. Reservation for SC/ST & OBC candidates will be as per the rules. However, in case of non-availability of candidates in reserved categories it will be filled from other Reserved Categories / General Categories.

4. **Qualification Criteria:** If the number of candidates is higher than five times against the number of Vacancies indicated, then the criteria to call for Interview will be based on final percentage marks obtained in Graduate/Diploma of candidates.

- Candidates, who fulfill all the above conditions, can only apply.

- The candidates should not have completed or undergoing apprenticeship training in other organization.
- Candidates who have already completed their apprenticeship or terminated their apprenticeship mid-way or pursuing their apprenticeship with other organizations are not eligible.
- The shortlisted candidates will be called for written test / interview through their mail ID / SMS.

- Canteen facilities will be provided at subsidized rates.
