MINIMUM EDUCATION QUALIFICATION:

Category-I Graduate Apprentices:-

1. The Degree in B.Sc., B.Com, B.A. granted by a Statutory University in relevant discipline.
2. A Degree in B.Sc., B.Com, B.A. granted by an Institution empowered to grant such degree by an Act of Parliament in relevant discipline.
3. Graduate examination of professional bodies recognized by the State Government or Central Government as equivalent to above.
4. Candidate should have passed all the previous semesters of his graduation and should have passed the qualifying semester of his graduate examination after March 2020.

6. The eligibility, stipend and reservation for SC/ST/OBC & other in the apprenticeship training as per the Apprenticeship Act-1961 and amended from time to time. Applicant will follow all the rules and regulations as decided by Haffkine Institute.
